

**INNER MONGOLIAN PEOPLE'S PARTY  
STATEMENT OF CLARIFICATION ON XI HAIMING'S  
CONTINUOUS FALSE REPRESENTATION OF  
INNER MONGOLIAN PEOPLE'S PARTY**

**Inner Mongolian People's Party**

**May 29, 2018**

Xi Haiming, aka. Temtselt Shobtsuud, was the President (also referred to as “Chairman”) of Inner Mongolian People’s Party (IMPP) since the organisation became public in North America in 1997. On March 1, 2015, the Executive Committee of the Inner Mongolia People's Party (IMPP) convened an urgent meeting, and on that meeting a resolution was passed by a vote of strong majority to remove Xi Haiming, from the post of party president. The resolution was based on the facts that Mr. Xi had repeatedly violated the guiding principle, ultimate goal and organisational rules of IMPP, and through his actions and speeches which are in apparent betrayal of the indigenous Mongolian people’s trust and fundamental rights, impacted negatively both the cause of IMPP and the entire Southern Mongolian freedom movement.

We have been aware, however, that Xi Haiming, after his dismissal from the post, has continually been misrepresenting and falsely acting as the president of IMPP, and thereby kept on damaging the image of our organisation and hurting the Southern Mongolian freedom movement. We therefore, deem it necessary to make some clarification on Xi Haiming’s past role in IMPP, reason for his dismissal and other related matters.

1. While IMPP President, on many an occasion, disregarding and disrespecting organisational procedures, Xi had imposed on the Party his own so called “Dual Ownership” theory which is in serious conflict with the guiding principle and the ultimate goal of IMPP. The so called “Dual ownership” negates the indigenous Mongolians’ place in history as being the rightful owner in the region of Southern Mongolia, promised equal ownership to the invading Chinese colonialists, and thereby violated the fundamental interests of the Mongolian people.
2. Without any formal discussion or approval from the party, he publicized his so called “new policy” of “quitting independence” for Southern Mongolia while the IMPP charter, not only then, but also today, clearly states that the party’s ultimate goal is to end the colonial rule of China in Southern Mongolia and to achieve independence.
3. When faced criticism from both within and without the party, he took criticisms as personal attacks, or even plots to intentionally discrediting him and consequently taking away his “power”. Out of this defensiveness, he frequently carried out personal attacks on members and supporters of the party, accused them as Chinese spies and traitors without any basis whatsoever. Ironically, on many occasions, often under the influence of alcohol, he himself expressed that rather than giving up his “power” within the party, he would consider going back to “Inner Mongolia” to collaborate with the Chinese

authorities. In order to fend off some of the criticisms, in an irresponsible and dishonest manner, he even claimed more than once that he no longer is a member of IMPP, let alone its president, all the while there was never such official procedure took place, until the abovementioned urgent meeting on March 1, 2015.

4. Xi Haiming's years of indulgence in alcoholism had also contributed to his serious lack of judgment, failure in self-discipline and, above all, lack of personal integrity. On more than a few cases, he participated important international functions intoxicated, harassing others and disturbing peace, thereby injuring our party's reputation and negatively impacting our cause. More intolerably, he is in the habit of making telephone calls after intoxication, often at inappropriate hours, to people including those who are living under the censorship of Chinese security apparatus, revealing sensitive organizational details and also accusing others, while he is well aware that his every word is being monitored by the Chinese authorities. It should be pointed out that with or without alcoholism, his divisive and destructive behavior hurt not only those who are around him, it also seriously damaged the image of our party and the Southern Mongolian cause.

We welcome and appreciate those who are sympathetic toward our struggle to work with us and support our cause. For that matter, we have no objection to anyone working with Xi Haiming on Southern Mongolia-related matters, as long as such cooperation is conducted with him as an individual or whatever organisation that he is genuinely part of, other than IMPP. We simply urge groups and individuals to use caution in going along with whatever organisation or official title that he may claim for himself, to avoid playing part in his continuous destructive acts of damaging IMPP's image and Southern Mongolian freedom movement.
